The minimum dollar value that can be loaded is \$5 and the maximum total value on your card cannot exceed \$100. You may not return or cancel your Wimpy's Diner Gift Card after it is received or purchased.

REDEMPTION

Wimpy's Diner Gift Cards are available for redemption in store only at participating locations.

VIEW YOUR BALANCE

To view your Wimpy's Diner Gift Card balance, go to Check Balance.

LOST OR STOLEN GIFT CARDS

The Wimpy's Diner Gift Card can not be refunded if stolen, lost or destroyed.

LIMITATIONS

You may not use a Wimpy's Diner Gift Card to purchase other Gift Cards. Wimpy's Diner Gift Cards can not be resold or redeemed for cash.
